- 2.1 JUDICIAL OFFICE TAKES PRECEDENCE

- 2.4 DON'T BE INFLUENCED BY EXTERNAL THINGS

- 2.7 ITS JUDGES RESPONSIBILITY TO DECIDE

SYSTEM

- 3.1 AVOID EXTRAJUDICAL ACTIVITIES THAT INTERFERE WITH JOB DUTIES OR UNDERMINE JUDICIARY DUTIES AND RESPONSIBILITY
- 3.2 DON'T VOLUNTARILY GO TO A PUBLIC HEARING OR CONSULT WITH AN EXECUTIVE OR LEGISLATIVE BODY UNLESS ITS APPROPRIATE
- 3.3 DON'T TESTIFY AS A CHARACTER WITNESS UNLESS SUBPOENAED
- 3.4 AVOID APPOINTMENTS TO GOVERNMENT POSITIONS UNLESS IT RELATES TO THE LEGAL

- 3.5 DON'T DISCLOSE NONPUBLIC INFORMATION
- 3.6 DON'T AFFILIATE WITH DISCIMINATORY ORGANIZATIONS
- 3.7 BE SMART WITH EDUCATIONAL, RELIGIOUS, CHARITABLE, FRATERNAL AND CIVIC ORGANIZATIONS
- 3.8 AVOID APPOINTMENTS FOR FIDUCIARY POSITIONS
- 3.9 DON'T BE AN ARBITRATOR OR MEDIATOR

- 3.11 DON'T LET INVESTMENTS INTERFERE
- 3.12 MAKE SURE COMPENSATION FOR EXTRAJUDICIAL ACTIVITIES IS REASONABLE
- 3.13 BE SMART ABOUT RECEIVING GIFTS
- 3.14 BE SMART ABOUT REIMBURSEMENT
- 3.15 REPORT REQUIRED

CANON 4

- 4.1 AVOID POLITICS BEST YOU CAN
- 4.2 DURING ELECTION CAMPAIGNS-ACT APPROPRIATELY AND FOLLOW RULE 4.2
- 4.3 APPOINTIVE CANDIDATE JUDGES CAN COMMUNICATE DIFFERENTLY AND SEEK ENDORSEMENTS
- 4.4 CAMPAIGN COMMITTEES BE SMART DURING ELECTIONS CANDIDATE IS RESPONSIBLE
- 4.5 NONJUDICAL OFFICES UPON BECOMING CANDIDATE FOR NONJUDICIAL ELECTIVE THE JUDGE MUST RESIGN
- 4.5 UPON BECOMING CANDIDATE FOR NONJUDICIAL APPOINTED OFFICE – NOT REQUIRED TO RESIGN IF COMPLIANT
- NO JUDICIAL CANDIDATE CAN NOT SIMULTANEOUSLY BE CANDIDATE FORELECTED NONJUDICIAL POSITION

JUDGES GONE WRONG

- In Utah, a judge texted a video of a man's scrotum to court clerks. He was reprimanded but remains on the bench.
- In Indiana, three judges attending a conference last spring got drunk and sparked a 3 a.m. brawl outside a White Castle fast-food restaurant that ended with two of the judges shot. Although the state supreme court found the three judges had "discredited the entire Indiana judiciary," each returned to the bench after a suspension.
- In Texas, a judge burst in on jurors deliberating the case of a woman charged with sex trafficking and declared that God told him the defendant was innocent. The offending judge received a warning and returned to the bench. The defendant was convicted after a new judge took

over the case.
